

## Financial Support

The School offers a limited number of places for Financial Support for Standard Rate Tuition Fees. Financial Support is not available on the Discounted Rate nor does it apply to Pre-School Fees. There will not necessarily be any Financial Support places in a prospective student's year group at any particular time. Availability of places will depend upon the overall enrolment per grade.

Applications for Financial Support will not be accepted from families who are in receipt of either full or partial corporate support or who require Learning Support or EAL (English as an Additional Language).

Eligibility for Financial Support is determined by the following criteria:

- the family's ability to afford the Tuition Fees as assessed by the School Finance Committee
- the student's ability to bring exemplary academic work to ISA
- the student's ability to contribute to the positive social climate of ISA

Financial Support is awarded on an annual basis. The student's standing at school, together with continuing need is considered by the Finance Committee in determining the renewal of support.

**Families awarded Financial Support are still responsible for the full cost of the Capital and Registration Fees.**

## Application Instructions for Financial Support

All information will be treated as strictly confidential and will be reviewed by the School Finance Committee without reference to the student's name.

### External Students applying to ISA

To be eligible for support, a student must be eligible for admission to ISA. To avoid misunderstandings, a decision on admission will not be communicated to parents until the financial award has been determined.

Please submit the following forms together:

1. Enrolment Form
2. Copy of the photograph/information page of the student's passport
3. School records/official transcripts for the past three years, including available standardised testing results
4. Application Form for Financial Support
5. Documentation such as government statements of income and/or Tax Returns (UK Form P60 or US Income Tax Return Form 1040 with all schedules)  
These documents should be for the last tax year
